Victorian Organic Retailer Award goes to... A Passionate Business

Passion Foods, a leading organic retailer/cafe in South Melbourne, has won the Melba Fresh Organic Victorian Organic Retailer of the Year 2009 Award.

The award was a highlight of National Organic Week (NOW) which ran from 16 – 25 October showcasing approximately 130 organic awareness-raising events and activities around Australia.

The awards were judged by an expert panel including a large-scale organic producer, a prominent organic food manufacturer and wholesaler, a consumer representative and representatives from the organisers Biological Farmers of Australia (BFA) and Centre for Organic & Resource Enterprises (CORE). Nominated businesses were judged on motivation, promotion, interface with local suppliers, environmental initiatives and customer loyalty and promotion strategies.

Nominees were required to be Australia-based and to source more than 70% of their fresh horticultural product as “certified organic” or “certified organic in-conversion”.

The award was sponsored by Melba Fresh Organic; Melbourne markets-based third generation fresh produce wholesalers.

Steven and Sharlene Klotnick, owners of eco-living fine foods supermarket *Passion Foods*, are delighted to receive the Award.

“The Award is a wonderful surprise and we’re very excited to receive it,” Steven says.

“We’re very passionate about what we do and we all work hard to achieve results in the store, supplying people with good organic food. We’ve owned *Passion Foods* for only seven months but already we have customers saying the Award is well deserved; it’s great to get feedback like that.”

Holly Vyner, General Manager of BFA, sees the Awards as a natural part of the steady growth and integration of the organic industry.

“Retailers are important in driving industry growth through making organic produce accessible, educating consumers about the benefits of organic food and being a face for our Industry,” she says.
